**Estimated Costs**

**2023 Group of Experts of the High Contracting Parties to Amended Protocol II\***

1. The Twenty-fourth Annual Conference of the High Contracting Parties to Amended Protocol II to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons which May Be Deemed to Be Excessively Injurious or to have Indiscriminate Effects, to be held in Geneva on 15 November 2022, is to decide to convene a meeting of the Group of Experts of the High Contracting Parties in 2023.

2. This document is submitted to assist the decision of the High Contracting Parties. The Sixth Review Conference, held in Geneva on 13-17 December 2021, adopted a budget for the 2023-25 period as contained in CCW/CONF.VI/9 (CCW/CONF.VI/11, paragraph 32), including the cost estimates of the Group of Experts of the High Contracting Parties to Amended Protocol II. In accordance with this decision, the estimated costs of US\$ 33,100 for a 1.5-day meeting and US\$ 33,400 for a two-day meeting for 2023 are identical to the cost estimates of the 2022 Group of Experts adopted by the Twenty-third Annual Conference of High Contracting Parties to Amended Protocol II held in December 2021, plus the 5% contingency (CCW/AP.II/CONF.24/3, CCW/AP.II/CONF.24/3/Corr.1<sup>1</sup>). A breakdown of these costs is provided in the attached table.
