Addendum

The San José progress report was warmly welcomed by the Fifth Meeting of States Parties at its final plenary meeting, on 5 September 2014. After the conclusion of the Fifth Meeting, Belgium, Canada, the International Federation of Red Cross and Red Crescent Societies, the Cluster Munition Coalition and the Office for Disarmament Affairs of the United Nations Secretariat suggested the following amendments to the progress report:

1. Paragraph 9

At the end of the paragraph, *add*

Since then, one signatory has completed the destruction of its stockpiles of cluster munitions.

2. Paragraph 15

After the International Committee of the Red Cross (ICRC) *insert* national Red Cross and Red Crescent societies

3. Paragraph 22

At the end of the paragraph, *add*

On 8 April 2014, the Secretary-General of the United Nations sent letters to States not party to the Convention inviting them to consider joining the treaty.



4. Paragraph 25, second sentence

For 151 States read 152 States

5. Paragraph 25, last sentence

For five read 20

6. Paragraph 29

The last sentence *should read*

One signatory²⁹ indicated in its voluntary article 7 report that it had completed the destruction of its remaining stockpiles of cluster munitions and was not retaining any stockpiles for purposes permitted by the Convention.

7. Paragraph 33

For eight read nine

8. Paragraph 51, first sentence

For three read four

9. Page 6, footnote 20

The footnote *should read*

Cambodia, Netherlands, New Zealand, Norway and Zambia, in addition to the 15 members of the Security Council, which have expressed their concern about reports of cluster munitions use in South Sudan in resolution [2155 \(2014\)](#).

10. Page 7, footnote 24

The footnote *should read*

Bosnia and Herzegovina, Botswana, Bulgaria, Croatia, France, Germany, Guinea-Bissau, Italy, Japan, Mozambique, Peru, Spain, Sweden and Switzerland.

Following the publication of the Cluster Munition Monitor 2013, Canada completed the destruction of its stockpiles of cluster munitions.

13. Page 12, footnote 63

At the beginning of the footnote, *insert* Angola

- 14. Annex I, table entitled “Stockpile destruction and retention”, columns headed “States parties retaining stockpiles for training purposes” and “States parties that have provided information on retained stockpiles”**

At the beginning of the entry, *insert* Belgium

- 15. Annex I, table entitled “Transparency reporting”, column headed “Signatories that have voluntarily submitted article 7 transparency report and updates”**

The entry *should read* Canada (2011, 2012, 2013 and 2014), Democratic Republic of the Congo (2011, 2012 and 2014), Palau (2011)
